सामेल गरिएको जानकारी गराए। उनले मनसुन अगावै हितधारकहरूसित समन्वय सभा आयोजन गर्ने आश्वासन पनि दिए। उनले अपेक्षित परिणामको निम्ति सबैलाई मिलेर काम गर्न आग्रह गरे। बैठकमा नगर निगम आयुक्त हेम कुमार छेत्रीले निगमको आपदा तयारी गतिविधिहरूबारे जानकारी दिए। यस क्रममा उनले पार्षदगणद्वारा आआफ्नो क्षेत्रमा झोडा

GMC and SSDMA hold pre-monsoon preparedness meet

GANGTOK, 19 APR (IPR):

A pre-monsoon preparedness meeting for Gangtok Municipal Area was organized by Gangtok Municipal Corporation in collaboration with Sikkim State Disaster Management Authority [SSDMA] in the Conference Hall of the Gangtok Municipal Corporation on 19 Apr, 2022.

The meeting was chaired by Minister, Kunga Nima Lepcha, Land Revenue & Disaster Management Department and was attended by Mayor, Deputy Mayor, Councilors along with Commissioner, Gangtok Municipal Corporation and Staff. SSDMA was represented by State Relief Commissioner cum Secretary, Director (SSDMA), and officers from SSDMA.

The meeting commenced with Commissioner, Hem Kumar Chettri, GMC welcoming the chief guest and dignitaries. He also gave a brief background on the Disaster Preparedness activities that GMC has initiated and also mentioned that the Councilors have actively taken part in clearing clogged jhoras in their respective areas. This was followed by a short presentation on the Role of Municipalities in Disaster Risk Reduction. The presentation covered the role of GMC, SSDMA, and DDMA in Disaster Preparedness



and Mitigation.

Thereafter, the house was opened for discussion, Minister, Land Revenue & Disaster Management recalled the incident of monsoon calamity of the year 1997 in which different parts of Gangtok were affected and many people had lost their lives. One reason was poor drainage of water leading to clogged jhoras, therefore he emphasized keeping jhoras free from hindrances. Thereafter the following were suggested by different councilors:

The Deputy Mayor suggested that the disaster preparedness and sensitization programme should be a regular practice and it should also be conducted for the volunteers from wards. Arithang councilor suggested a

single point of contact for easy distribution of relief in case of a calamity. MG Marg Councilor thanked the State Government for budgetary allocation for cleaning the backside jhoras of the market area. Bojoghari Councilor brought out the problem of dumping of waste by road construction agencies. Lower Sichey Councilor suggested that necessary mitigation efforts should also be focused on low lying areas. Panihouse Councilor spoke on clearing of all construction materials after completion of work by the agencies.

Relief Commissioner cum Secretary, Sarala Rai while thanking the Councilors for their suggestions informed the house that a separate Budgetary

allocation has been sanctioned by the Government for Disaster Mitigation at Municipal Areas. She assured the house that all issues that need redressal will be taken up swiftly with stakeholders immediately. She further added that the Councilors should send names of interested volunteers to be trained under the Aapda Mitra Scheme.

Director, Prabhakar Rai, SSDMA highlighted SSDMA's role in Disaster Preparedness and Mitigation, he spoke on the institutional Management of Disaster management in the State. He also empathized on following the prescribed SDRF norms for immediate relief management and suggested that relief work should be carried out with due priority to vulnerable areas. While

echoing the suggestion of the Secretary he requested the councilors to work in tandem with SSDMA to make a disaster-resilient municipal area with an effective City Disaster Management Plan (CDMP).

Mayor, Nell Bahadur Chettri, GMC thanked the Minister for chairing the meeting while adding that it was the first time that a cabinet minister had chaired such a meeting. He opined that councilors should be informed if there are any developmental works or activities that take place in their wards so that better coordination can be achieved. He further thanked the department for taking the initiative of holding the meeting and assured of all support from GMC.

The Minister in his address credited the

councilors for being active and honest with their suggestions and he assured that all possible assistance will be given by the department. He emphasized that disaster preparedness should be taken up at all levels, he said that the best ambassadors for taking the message of disaster preparedness forward are the school children. He informed the house that topics of disaster management have been added to the school syllabus. He also assured the house that a coordination meeting with stakeholders will be taken up before the start of the monsoon. At the end, he requested the house to work in coordination to achieve the desired outcome.

The meeting ended with a Vote of thanks by the Director, SSDMA.
