Bey landslide cuts off Upper Dzongu, two casualties suspected



Dikchu, 26 May [SR Report/IPR]: Upper Dzongu has been totally cut-off from the rest of the state by the landslides which hit the area in the evening of 24 May. The existing suspension foot bridge connecting Bey to Sakyong and Pentong villages have been washed away. At present Sakyong and Pentok has been cut off from rest of the state. As per the ground report, an urgent requirement of a

suspension foot bridge is required immediately, informs a team constituted by the North District administration.

The massive rainfall followed by landslide at Myong Kyong at Bey, Upper Dzongu had washed away 03 kutcha houses belonging to one Samten Lepcha of Bey including the house of Chandra Bdr Tamang [67] his wife, who are missing till the time of filing this report. It is informed that both husband and wife were working for an under-construction SPWD bridge in the locality and the officilas and neighbour who visited the spot assumed that they have been swept away by the slide alongwith thier house.

It is also been reported that the neighbours whose houses were also damaged by the slide manged to flee away safely. The area MLA, Pintso Namgyal Lepcha alongwith RO Dzongu and his team from Subdivisional Administration, Dzongu visited the site on the morning 25 May.

The deceased have been recorded missing as their bodies have not been traced. The search operation could not take place because of the bad weather, it is informed. The SDRF along with the team of District administration

have been deployed for the search operation.

On the other hand, the masive rainfall had also damaged 11 other houses in the locality. All the residents have been evacuated and sheltered to their relative's houses. The District administration had proposed Lingzya JHS building as an immediate relief camp.

The DE Roads as a part of the inspection team has been directed to submit a short term plan immediately for restoration of connectivity at the earliest. A long term plan for the permanent restoration connectivity has also been sought. It was also reported that the villagers has also lost livestocks in huge numbers. The details of these losses along with the extent of the land damage are being put up for payment of ex gratia, as per the prescribed NCRF norms.

The panchayats who were part of the inspection team have been directed by to whether the proposed relief camp needs to be made functional as some of the victims maintained that they are comfortable in staying with their relatives.

However, distribution of ration and other essential items for the affected villagers will be arranged by the administration.

Bey mudslides claim two lives, two villages cut-off in Upper Dzongu

GANGTOK, May 26: The couple who was washed away in a massive mudslide near Bev in Upper Dzongu on Sunday evening have not been traced so far. The slide had occurred at around 5 pm which swept away the couple along with three kutcha houses, informs an IPR release from Mangan today.

The site of incident is Myong-Kyong, 12th Mile, Bey.

Chandar Bahadur Tamang (67) and his wife were swept away. They were engaged as workers in the underconstruction SPWD bridge and are reported to be Nepal nationals

MLA Pintso Namgyal Lepcha visited the site on Monday morning.

The two deceased have been recorded as missing as their bodies have not been traced on account of the massive slide which has significantly changed the demography of the place. The search operation could not take place on account of the weather conditions. The SDRF have been requisitioned by the district police for the search operation today.

Eleven other houses have been damaged and the households have been evacuated and shifted to the houses of their relatives, the IPR release mentions.

The government junior high school at Lingzya near Bey has been identified as the



relief camp.

"The panchayats who were part of the inspection team have been told to ascertain by tomorrow as to whether this relief camp needs to be activated as some of the victims were more comfortable putting up with their relatives. However, distribution of ration and

other essential items for the washed away houses will be arranged by the administration," the IPR release mentions.

The existing suspension foot bridge connecting Bey to Sakyong and Pentok villages have been totally washed away thereby cutting off these two villages

completely. Urgent requirement of a suspension foot bridge is felt.

The divisional engineer of the Roads & Bridges department, who was part of the inspection team, has been directed to submit a short term plan as soon as possible for restoration of connectivity at the earliest. A long term plan

for permanent restoration of connectivity has also been sought. Apart from the loss of lives, loss of livestock has also reported. The details of these losses along with the extent of land damage are being put up for payment of ex-gratia, as per the prescribed NCRF norms, the release mentions.
