#### NOTIFICATION

Dated: 02.02.2016

In exercise of the powers conferred by sub-section (1) section 14 of the Disaster Management Act, 2005, (53 of 2005) and in supersession of notification No. 136/Home/2010, dated 30/11/2010, published in Extra-Ordinary Gazette No. 666 dated 30<sup>th</sup> November 2010, the State Government hereby constitutes the "Sikkim State Disaster Management Authority" consisting of the following members, namely:-

(1)	Chief Minister of Sikkim	-	Chairperson, Ex-Officio
(2)	Prof. V.K. Sharma	=	Vice Chairman
(3)	Chief Secretary, Govt. of Sikkim	_	Chief Executive Officer
(4)	Director General of Police	=	Member
(5)	Secretary, FRED	_	Member
(6)	Secretary, Home Department	-	Member
(7)	Secretary, Mines, Minerals & Geology Department	-	Member
(8)	Secretary, UD & HD	-	Member
(9)	State Relief -Commissioner-cum-Secretary, LR & DMD	-	Member/Convener

- The State Disaster Management Authority (SDMA) shall be an Authority for:-
  - (a) Declaration of disaster situation and disaster areas with boundaries.
  - (b) Declaration of Emergency and mobilization of resources including manpower for disaster management that may be relief work, rehabilitation, reconstruction, search and rescue, as the case may be at the time of occurrence of disaster.
  - (c) Declaration of disaster prone zones with boundaries and issuing of Notification for un-safe areas.
  - (d) State Disaster Management Action Plan and Policy.

- (e) Constitution of Standing Technical Committee and Tactical Team for State level and District Level.
- (f) Hazard mitigation plan and also providing resources and all other services needed for disaster management.
- (g) Capacity building and preparedness and response plan.
- (h) State Disaster Management Codes and Techno-Legal regime.
- (i) Incorporation of essential components of the disaster reduction prevention and mitigation to the socio-economic development planning.
- (j) Making available the support of regional, international experiences, knowledge, resources in risk reduction and disaster management.
- (k) Monitoring of costs related to disaster management procurement of heavy equipments, time recording, cost analysis and overall fiscal guidance, standard Operating Procedure for State Level Disaster Management team and requirement of staff in the disaster management division.
- Integration of the Incident Command System in the existing Disaster Management system and also, any other issue related to State Level Disaster Management.
- (m) State Network of Emergency Operation Centres, Control Room's Function, monitoring of daily situation of disaster occurrence in the State and actions to be taken thereof by State Government, Government of India, Organizations situated outside state of Sikkim.
- Notwithstanding anything contained in any other law, State Disaster Management Authority in the performance of its functions for the purpose of safety of life and property of public, may issue directions in writing to any person, Officer of organization and such persons, officer or organization shall be bound to comply with such directions.
- The Secretary, Land Revenue and Disaster Management shall convene meeting from time to time to review the progress made on the above issues and necessary steps to be taken for prevention and mitigation of disasters.
